Disruptive behavior could result in the suspension of a member's rights and vote as a delegate of the International congress for that given year. The final decision on punishment shall be decided by a 2/3 vote from the congress. - Michael Gendreau (CT) seconded and spoke for the amendment, Eric (PA), Zach Hall (AR) spoke for the amendment. Danny Johnson (Montana) spoke against. McLean Haughey (FL) motioned to table the amendment, Daniel Cunningham (VT) seconded. McLean rescinded the motion to table. **Passed.**

- Zach Williams (NY) motioned to amend the amendment "punishment shall be decided by a 2/3rd vote from the Congress Officer, after which it will go to Executive Officer decision", seconded. Tony Peebler (TX), James Porter (Wyoming) spoke for. Greg Fyffe (OH) spoke against. Moved to table Call Item 1 for lunch at 11:00 AM. James Porter (Wyoming) moved to bring off table, seconded.
